**4-H CLUB GAME OR SALES BOOTH**

Any 4-H Club may do a fundraising effort at the 4-H Fair. It may be a carnival type game or selling a product you have made or bought to benefit your club. These booths should have your club name visible and be decorated to tie into the 4-H Fair theme. 4-H games and sales exhibits are given top priority and are not charged a fee, but it is important to abide by the terms of the contract and to adhere to all of the deadlines.

**All 4-H Club Game Booths must be registered by MAY 2, 2025\***

**All 4-H Club Sales Booths must be registered by JUNE 2, 2025.**

**There are three rules governing this application:**

1. 4-H Game and Sales Booths must be designed, decorated, etc. by the 4-H club members under the direction of 4-H Leaders and/or parents.
2. Games/Sales Booths must be set up on the Fairgrounds before 3:00 pm on the Thursday of Fair and remain throughout the three days of the Fair.
3. All game and sales booths MUST have a contract and be approved by the 4-H Fair Committee.

**\*GAMES OF CHANCE** If you are conducting a game of chance or skill, **you must** secure an Amusement Games License from the State of New Jersey. Applications are available from the Middle Township Clerks Office, but must be processed through the 4-H Foundation, Inc. **You must submit your Games application to the 4-H Foundation, Inc. by May 2 so** the proper paperwork can be submitted. The license requires a minimum of two (2) months for processing. All workers staffing these booths must be over the age of 18.
